RECITALS:

A. Pursuant to Public Act No. 188 of the Public Acts of 1954 (the Act), the Hadley Township Board established a special assessment district for maintenance of Fair Acres Drive and the Supervisor has prepared a special assessment roll describing all parcels of land to be assessed, the names of the respective record owners, and the total amount to be assessed against each parcel per year for each of the next five (5) years.

B. The Hadley Township Board has conducted a Public Hearing to review and consider any objections or comments to the special assessment roll for the maintenance of Fair Acres Drive for the next five (5) years pursuant to proper notice in compliance with the Act.

C. The Act provides that, following the public hearing, the Township Board may confirm, amend, or correct the special assessment roll or refer it back to the Supervisor for revision or direct a new roll to be made.

NOW, THEREFORE, BE IT RESOLVED:

1. The special assessment roll for Fair Acres Drive as presented is hereby confirmed.
2. If any assessment is not paid when due, then the assessment shall be considered to be delinquent and there shall be collected a penalty at the rate of One (1%) percent for each month, or fraction of a month, that the assessment remains unpaid before being reported to the Township Board for reassessment on the Township tax roll in accordance with the Act.
3. The assessments to be made in the special assessment roll are hereby ordered and directed to be collected by the Township Treasurer and the Clerk shall deliver said special assessment roll to the Treasurer with her warrant attached, commanding the Treasurer to collect such assessments in accordance with the direction of the Township Board and the Act.
