- 1) Zoning Ordinance Update
  - i. Review latest materials from Rowe PSC
    - Discussion regarding proposed new Lake Lapeer District. When meeting with the residents of Lake Lapeer it was discovered that the proposal regarding lowering the minimum lot size was not favored so Rowe has now amended the Lake District proposal to having 2 Lake Districts with Lake Lapeer staying with current minimum lot size. Rowe went over the Table of Uses, where we define what areas of the township are currently zoned and if there were any changes suggested.

Our next step in this process will be to discuss definitions at our next meeting. We estimate that we will have 3 to 4 more meetings to finish the process.

 Hadley Township Five Year Parks and Recreation Plan Status update – the Board has reviewed the proposed plan and has put it out for 30-day public review. We anticipate that barring any unforeseen circumstances the plan may be adopted in the May Township Board Meeting.
