Supervisor Monroe shared that the dangerous building on Diehl Rd. has been demolished so the issue is now closed. He then gave a recap of the speed survey that was completed in the downtown area.

# TRUSTEES' REPORT

In Trustee Brandt's absence, there was no road report.

Trustee Hartwig gave a synopsis of the last Planning Commission meeting which highlighted: the draft of new Zoning Ordinance will be completed in February or March, the January meeting has been moved to the 23<sup>rd</sup> of January, this year's projects will include reviewing the Special Land Use permits to see if they are still being used, and updating the wind and solar ordinances to reflect the State's changes, and finally nominations for Secretary and Chairperson.

## FIRE REPORT

Runs: (13 runs: 2 Fire; 12 EMS) Chief Nass said the fire department had 257 runs in 2023, and informed the board that the new truck may not be here until the next fiscal year.

# **PUBLIC TIME**

County Commissioner Knisely briefed the board on the following: meeting dates and times for the Lapeer County Commissioners were set for 2024, a solid waste committee was established that Knisely will chair, they hired The Kelly Firm for legal representation, they are considering ProQA for 911 dispatch, engineering plans are being drawn up for the expansion/renovation of the Animal Control building, Knisely heads the IT Committee and they are looking into new accounting and payroll software for the county as well as cybersecurity.

# RESOLUTION Speed Limit Set to 35 MPH Along Hadley Rd., from Pratt Rd. south Hadley Township

Hadley Township Board offered the following Resolution during a regular Board Meeting and moved for its adoption:

Roll Call: Hartwig: aye, Schultz: aye, Monroe: aye; motion carried.

WHEREAS, Michigan Vehicle Code Act 300 of 1949, Section 257.627 (9) establishes the "general speed limit" of a county road to be fifty-five (55-mph) miles per hour; and

WHEREAS, a fifty-five (55-mph) miles per hour speed limit on Hadley Road from Pratt Road southerly 0.50 miles, is believed to be hazardous to pedestrians and bicyclists; and

WHEREAS, Michigan Vehicle Code Act 300 of 1949, Section 257.627 (2) (h) states that the County Road Commission may establish a statutory speed limit not exceeding thirty-five (35-mph) miles per hour based on vehicular access points;

**NOW THEREFORE BE IT RESOLVED**, that the Hadley Township Board supports a thirty-five (35-mph) miles per hour speed zone along Hadley Road from Pratt Road southerly 0.50 miles.

WHEREAS, Michigan Vehicle Code Act 300 of 1949, Section 257.627 (9) establishes the "general speed limit" of a county road to be fifty-five (55-mph) miles per hour; and

WHEREAS, a fifty-five (55-mph) miles per hour speed limit on:

- Pratt Road from Hadley Road west 0.4 miles
- Pratt Road from Hadley Road east 0.3 miles
- Hadley Road from Pratt Road north 0.3 miles

is believed to be hazardous to pedestrians and bicyclists; and

WHEREAS, Michigan Vehicle Code Act 300 of 1949, Section 257.627 (2) (j) states that the County Road Commission may establish a statutory speed limit not exceeding forty-five (45-mph) miles per hour based on vehicular access points;

**NOW THEREFORE BE IT RESOLVED**, that the Hadley Township Board supports a forty-five (45-mph) miles per hour speed zone along:

- Pratt Road from Hadley Road west 0.4 miles
- Pratt Road from Hadley Road east 0.3 miles
- Hadley Road from Pratt Road north 0.3 miles
