Treasurer Schultz said her office is quiet right now, but she gave a brief report on the March LCEMS meeting.

CLERK'S REPORT

Clerk Daly gave all the board members a copy of the budget for their review, and reminded everyone attending of the following items on the calendar: May 7 special election, June 6-8 Hadley's Twp. Wide Garage sale, tire recycling is April 27 from 9am to noon, and there is a hazardous waste drop off by appointment on May 1 at the Habitat for Humanity.

SUPERVISOR'S REPORT

Supervisor Monroe shared that he called an electrician about the township office parking lot lighting and will report back next month.

TRUSTEES' REPORT

In Trustee Brandt's absence, Supervisor Monroe gave a brief road report.

Trustee Hartwig explained that the Planning Commission has delayed updating the Zoning Ordinances until there are results of the initiative to maintain local control of wind and solar.

FIRE REPORT

Runs: (10 runs – 53 runs this year) Chief Nass told the board the firefighters refurbished the grass rig. He thanked the firefighters who worked on 7-42. The Chief said a new grass rig would run up to \$300,000 and their fix up was under \$5000.
