Meeting was called to order by Secretary Hill at 7:01 p.m.

Pledge of Allegiance was recited.

Roll call of members present: David Hinton, Linda Hodge, Ann Goodwin, Ron Shoemaker, Kim Hill, Elwyn Brandt, and Robert Hartwig. There were five members of the public present.

Approval of Agenda: Commissioner Hodge motioned to approve the agenda as presented, second by Commissioner Shoemaker. Motion carried.

Approval of Minutes: Commissioner Shoemaker motioned to approve the minutes of January 21<sup>st</sup> meeting as corrected, second by Commissioner Hodge. Motion carried.

Public Time: Ralph welcomed new planning commissioner Ann Goodwin.

Old Business:

1) 2025 Project Ideas:

Commissioner Shoemaker recommended we review the Township Ordinances to ensure they are in agreement with the new Zoning Ordinance.

Commissioner Hodge looked at the Dryden noise ordinance and found that it was very similar to the current Hadley ordinance. Discussion took place regarding how to place measurable noise restrictions in a noise ordinance. We agreed to look at the noise ordinance as part of the 2025 projects.

- 2) Nominations for Chairman – Secretary Hill Opened the floor for nominations for Chairman. Commissioner Hinton nominated Commissioner Goodwin for Chairman. Commissioner Goodwin accepted the nomination.
- 3) Election of Chairman – Commissioner Brandt asked chair nominee Goodwin why she wants to be on the Planning Commission. Commissioner Goodwin stated she wanted to be more involved in Hadley and contribute to the community. She highlighted her law enforcement training and her ability to deal with people. Roll call vote: Hinton – yes, Hodge – yes, Shoemaker – yes, Hill – yes, Hartwig – yes, Brandt – yes, Goodwin – yes. Commissioner Goodwin elected as Chair.

#### New Business:

- 1) ZBA Report – No current ZBA activity.
- 2) Township Board – Approved roadside mowing and brush axe. Commissioners Hill and Hinton reappointed to Planning Commission. Glenn Walton resigned from the PC. Ann Goodwin appointed to serve out the remainder of Glenn Walton's term.

Glenn Walton thanked everyone for serving with him on the Planning Commission.


#### Commissioner Comments:
